15. 1 Peter Griffin/Dennis Martin.

<u>It was resolved that:</u> after PA had confirmed that the hangar was over height in contravention with the approved drawings, the Secretary would write to PG thanking him for the improvement in the contents of the hangar and assuring him that the committee would be carrying out further inspections to ensure compliance. In the course of checking that the relevant hangars were in compliance with the approved drawings PG would be advised that his hangar was over height by 3 m and giving him one month to carry out the necessary approved modifications.

15.2 Bernie Stevermuer.

PA reported that Bernie had been in touch with him regarding the necessary modifications to allow him to sell his hangar. PA confirmed that their hangar was non-compliant in several ways but recommended that these be overlooked in this case to allow a prompt sale of the hangar.

It was resolved that: this be approved.

JA reported that he had written to Bernie giving him until 19 October to advise the committee that he intended to make a submission to the committee at its next meeting on 29 October. In the absence of such advice the committee would meet on 29 October and consider what measures should be taken in relation to Bernie Stevermuer.

15. 3 Keys to Fire Trail gates.

JA reported that he had written to Campbelltown City Council with copies to His Worship the Mayor, the Gen Manager, Ms. Lindy Dietz and to Mr Richard Blair, requesting an urgent meeting to discuss the change of locks to the gates on Lysaght Road. Having heard nothing by the end of the week JA rang the council and was assured that someone would ring back that day with an appointment. No such call has occurred.

It was resolved that: JA would ring Council again requesting an appointment.

It was further resolved that: BC would ring Hank Pinkster (General Manager, Illawarra Coal) and Frank Cook (South32 representative on Wollondilly Council's Environmenet Management committee) at the mine on Wednesday requesting an urgent meeting to discuss the locks on the gates
