NOTICES of MOTION

Below are two motions that will be addressed at the next General Meeting scheduled for 18th January. These two motions will each require a 75% majority as they involve changes to the club constitution.

NOTICE of MOTION (1)

"That <u>Part 6: Supplementary Rules</u>, Clauses 43 to 49 and the Appendices 1 and 2 be removed from the Club Constitution."

Moved: Jock Anderson **Seconded:** David Rittie

NOTICE of MOTION (2)

"That proxy voting is not permitted in the NSW SAC, and postal voting is permitted only on matters where advance information is provided such as the AGM, and will be carried out in accordance with the Associated Incorporation Regulation 2010 Schedule 3 and the clause 32 and 33 in the Constitution be replaced with the clauses as follows:

32: *Voting*

- (a) On any question arising at a general meeting of the association a member has one vote only.
- (b) All votes must be given personally or by post.
- (c) In the case of an equality of votes on a question at a general meeting, the chairperson of the meeting is entitled to exercise a second or casting vote.
- (d) A member or postal voter is not entitled to vote at any general meeting of the association unless all money due and payable by the member of the association has been received by the treasurer.

33:Postal Voting

Postal Voting will be carried out in accordance with the Associated Incorporation Regulation 2010 Schedule 3. The returning officer must, at least 14 days (or 21 days in the case of a special resolution) before the date fixed for the closing of the ballot, send by post or otherwise deliver to every member entitled to, and requesting a vote in the ballot, one set of the following material:

- (a) one ballot paper,
- (b) an envelope (in this Schedule referred to as the outer envelope') addressed to the returning officer and the reverse side of which is noted or printed with the name and address of the member,
- (c) a small envelope (in this Schedule referred to as the inner envelope)'in which the ballot paper is to be enclosed,
- (d) a copy of a statement prepared by the board setting out the terms of the resolution,
- (e) in the case of a special resolution a copy of a statement to the effect that the resolution is intended to be passed as a special resolution."

Cameras



der to the wheel regarding catering and Dave Rittie is helping with the Christmas Party. It never ceases to amaze me how many things are being done by volunteer members of this club. Thank you to all.

The Constitution

The Department of Fair Trading has confirmed in writing receipt of the updated Club Constitution which was approved at the last general meeting. This means that it has been officially registered with the Department. I have forwarded a copy to Don Harvie and in due course it will be published on the club website. In accordance with the Incorporated Associations Regulation 2010 the Constitution will now be known as the "Constitution" and not as the "Rules". As I foreshadowed in my previous Secretary's report two motions additional to those already published will be placed before the membership at the next General Meeting. These have already been circulated in the newsflash, but I will reproduce them here:-

NOTICE of MOTION (3)

"That clause 11 in the Club Constitution be replaced by clause 11 from the Model Constitution".

Moved: Vic Laybutt **Seconded:** Richard Thompson

FYI Clause 11 in the Club Constitution is:-

11: Disciplining of members

- (a) A complaint may be made to the committee by any person that a member of the association:
 - (i) has persistently refused or neglected to comply with a provision or provisions of this Constitution, or.
- (ii) has persistently and willfully acted in a manner prejudicial to the interests of the association. (b) The committee may refuse to deal with a complaint if it considers the complaint to be trivial or vexatious in nature.
- (c) If the committee decides to deal with the complaint, the committee.
 - (i) must cause notice of the complaint to be served on the member concerned, and
 - (ii) must give the member at least 14 days from

- the time the notice is served within which to make submissions to the committee in connection with the complaint, and
- (iii) must take into consideration any submissions made by the member in connection with the complaint.
- (d) The committee may, by resolution, censure, fine, suspend or expel the member from the association if,
 - After considering the complaint and any submissions made in connection with the complaint, it is satisfied that the facts alleged in the complaint have been proved, provided that no membershall be fined an amount exceeding the annual subscription of a full member of the association.
- (e) If the committee expels or suspends a member, the secretary must, within 7 days after the action is

taken, cause written notice to be given to the member of the action taken, of the reasons given by the committee for having taken that action and of the member's right of appeal under Rule 12.

- (f) The expulsion or suspension does not take effect:
- (i) until the expiration of the period within which the member is entitled to appeal against the resolution concerned, or
 - (ii) If within that period the member exercises the right of appeal, unless and until the association confirms the resolution under Rule 12 (e), whichever is the later.

FYI Clause number 11 in the Model Constitution is:-11. Disciplining of members

- (1) A complaint may be made to the committee by any person that a member of the association:
 - (a) has refused or neglected to comply with a provision or provisions of this constitution, or
 - (b) has willfully acted in a manner prejudicial to the interests of the association.
- (2) The committee may refuse to deal with a complaint if it considers the complaint to be trivial or vexatious in nature.
- (3) If the committee decides to deal with the complaint, the committee:
 - (a) must cause notice of the complaint to be

- served on the member concerned, and
- (b) must give the member at least 14 days from the time the notice is served within which to make submissions to the committee in connection with the complaint, and
- (c) must take into consideration any submissions made by the member in connection with the complaint.
- (4) The committee may, by resolution, expel the member from the association or suspend the member from membership of the association if, after considering the complaint and any submissions made in connection with the complaint, it is satisfied that the facts alleged in the complaint have been proved and the expulsion or suspension is warranted in the circumstances.
- (5) If the committee expels or suspends a member, the secretary must, within 7 days after the action is taken, cause written notice to be given to the member of the action taken, of the reasons given by the committee for having taken that action and of the member's right of appeal under clause 12.
- (6) The expulsion or suspension does not take effect:
 - (a) until the expiration of the period within which the member is entitled to appeal against the resolution concerned, or
 - (b) if within that period the member exercises the right of appeal, unless and until the association confirms the resolution under clause 12, whichever is the later.

NOTICE of MOTION (4)

"that clause 12 in the Club Constitution be replaced by clause 12 from the Model Constitution".

Moved: Vic Laybutt Seconded: Doug Stickland

FYI Clause 12 in the Club Constitution is: 12: Right of appeal of disciplined member

- (a) A member may appeal to the association in general meeting against a resolution of the committee under Rule 11, within 7 days after notice of the resolution is served on the member, by lodging with the secretary a notice to that effect
- (b) The notice may, but need not, be accompanied by a statement of the grounds on which the member intends to rely for the purposes of the appeal.
- (c) On receipt of a notice from a member under clause (a), the secretary must notify the committee which is to convene a general meeting of the association to be held within 28 days after the date on which the secretary received the notice.
- (d) At a general meeting of the association convened under clause (c):
 - (i) no business other than the question of the appeal is to be transacted; and
 - (ii) the committee and the member must be given the opportunity to state their respective cases orally or in writing, or both; and

- (iii) the members present are to vote by secret ballot on the question of whether the resolution should be confirmed or revoked; and
- (e) If at the general meeting the association passes a special resolution in favour of the confirmation of the

resolution, the resolution is confirmed.

FYI Clause number 12 in the Model Constitution is:12. Right of appeal of disciplined member

- (1) A member may appeal to the association in general meeting against a resolution of the committee under clause 11, within 7 days after notice of the resolution is served on the member, by lodging with the secretary a notice to that effect.
- (2) The notice may, but need not, be accompanied by a statement of the grounds on which the member intends to rely for the purposes of the appeal.
- (3) On receipt of a notice from a member under sub clause (1), the secretary must notify the committee which is to convene a general meeting of the association to be held within 28 days after the

date on which the secretary received the notice.

- (4) At a general meeting of the association convened under sub clause (3):
 - (a) no business other than the question of the appeal is to be transacted, and
 - (b) the committee and the member must be given the opportunity to state their respective cases orally or in writing, or both, and
 - (c) the members present are to vote by secret ballot on the question of whether the resolution should be confirmed or revoked.
- (5) The appeal is to be determined by a simple majority of votes cast by members of the association.

As with any motion to alter the Constitution, three (3) weeks notice must be given to the membership. This requirement will serve as that notice. It is anticipated

that the meeting at which these motions will be presented to the membership will be on Sunday, January 18th.

Correspondence

Correspondence has been relatively quiet during the last two months, and has mostly dealt with hangar matters.

Finally, I have heard that our special caretaker Rou has been struck down by a particularly nasty virus and even as I write, has been admitted to the respiratory unit in hospital. Please join me in wishing him a speedy recovery. We need you Rou and Dawn.

More Valuable Advice for Hangar Owners from Phil Ayrton

Below is the final instalment in the series sent in by our resident architect, Phil Ayrton, telling us about the process required for any intended hangar structural modification or internal fit-out. Thanks for the series of articles, Phil. *Ed*

<u>Hangar Modification Approval Process - Part 5</u>

Just when you thought we had dealt with this issue as completely as possible you now find out that there's more... The main stages we have described so far include the following:

- 1 Prepare Your Drawings,
- 2 Get the Club Stamp,
- 3 Submit to Lands Dept for owners signature, and
- 4 Submit to Wollondilly Shire Council,

with the additional final stage being:

5 Send a copy of the approved consent to Crown Lands.

The last time I received stamped drawings and the signed application and accompanying letter from Crown Lands, I noticed the accompanying letter contained an additional requirement that I have not previously been aware of. If you read the copy you keep for your records, it clearly states that once the application is approved by Council, a copy of the Council consent is to be forwarded to Crown Lands for their records, so this just means that to complete the process and to be completely compliant, you will need to make a copy of the

consent document only to send to Crown Lands, and an accompanying letter mentioning the hangar site by number is a good idea, as sometimes the consent document does not. No need to send a copy of the plans as they already have these, albeit without the addition of the council stamp.



So there it is in all its glory, the approval process for any works on your hangar. I will endeavour to put the document together and have it placed on the website for reference. Initially the process can seem a bit daunting but the best way is to just read the previous articles describing the process and tackle them one item at a time and you will be successful and ultimately delighted to know you are fully compliant, it's a nice feel-

ing and well worth the effort.

The first one, at Left, was taken by Bill Leighton of Manly Beach at dusk. (We hope he made it back to Wedderburn before last light!)


The next contender, at Centre Left, comes from Greg Ackman, which is another one of his delightful shots taken over Sydney. This

Also at dinner was ex member CARL HOLDEN and many tales both true and tall were exchanged over a plate of hot chicken soup.




